Prior case files on the meters such as PUC-15-20, 241 A.3d 481, 280 A.3d 975, No J-77A-L-2021, No 619 MAL 2020, No 620 MAL 2020, No 621 MAL 2020, No 622 MAL 2020, No 623 MAL 2020, No 624 MAL 2020, 15 C 10744, D068294, 6:15cv863, 16-208-SVR , 11 C 9299, and 5:16-cv-00058 prove entire communities have had to file lawsuits on the energy companies in other locations due to being abused. The kind of abuse they allow for is a human rights violation and is against the Geneva Convention. It is a crime against humanity.

17. Joshua tried to report the incidents on a local level until he was made aware the local community authorities were the one perpetrating the crimes against the community or those who were, were connected directly to the local community authorities and to the dept of health.

19. 2 Weeks after his wrongful incarceration, the FBI nationwide started investigating attacks on power substations. The people tied to the substation attacks were directly attached to KILLNET.

21. Unfortunately, the falsified pandemic which has now continued on has not only violated veteran, inmate, and community rights, but also everyone's human rights. It has deteriorated Louisiana's quality of life as if it wasn't already bad enough, and has allow extremist parties to utilize the submitted evidence to the United Nations as an everyday control mechanism.
